Hours/Schedule: Set-up 4pm till 5:30pm Teardown starts at 10pm cleared by Midnight.

Parking: There is no reserved parking for vendors Parking is only allowed on outside of venue.

Sales Tax Permit: A copy of your sales tax permit must be enclosed with your application.

Booth must be decorated in a festive holiday manner.

Confirmation/Refunds: Confirmations and space location will be mailed after application is accepted. Once accepted there will be no refunds.

Applications must be completely filled out! Include you check or money order and a self-addressed stamped envelope. A \$25.00 fee for any returned checks. Don't forget a copy of your sellers permit.
